

## 2008 Service Agreement - Production

This Agreement is by and between *GLIDE FX Steadicam Videography (GLIDE FX)* and \_\_\_\_\_ (Client(s)) on \_\_\_/\_\_\_/\_\_\_ for good and valuable consideration between the parties, which is hereby acknowledged and as described in the attached "2008 Service Invoice # \_\_\_\_\_" document, which is hereby incorporated by reference and is a part of this agreement.

\* *GLIDE FX* and/or the signed client reserve the right to terminate contract up to ninety(90) days prior to the agreed contractual service date without a "kill rate" penalty owed *GLIDE FX*. A "kill rate" of half(1/2) of the agreed upon full rate will be due *GLIDE FX* regardless of any cancellation by the signed client from ninety(90) days to thirty(30) days from the contractual service date(s). Payment in full will be due *GLIDE FX* regardless of any cancellation by the signed client within thirty(30) days to the contractual service date(s).

\* *GLIDE FX* is not responsible for circumstances beyond *GLIDE FX'S* control which would prohibit the completion of shooting by *GLIDE FX*, including but not limited to sudden equipment failure, unforeseen video tape defects resulting from the source of manufacture, adverse weather, etc.

\* *GLIDE FX* reserves the right to use client footage for promotional purposes without compensation and without notice to client for whom said footage was originally shot. *GLIDE FX* agrees not to duplicate client footage for resale, distribution or profit.

\* If the signed client uses footage shot by *GLIDE FX* in any video of a commercial nature that contains credits, credit shall be given to *GLIDE FX* under the heading "Steadicam Operator" with the use of "Kurt Jensen / *GLIDE FX*". *GLIDE FX* shall also be provided a copy of all raw footage shot by *GLIDE FX* for client and any edited, commercial, broadcast and/or retail ready content.

\* *GLIDE FX* retains full creative control over the finished look of any footage edited by *GLIDE FX*. If the contracted project is of a commercial nature, the signed client will be allowed one(1) re-edit with any desired changes at no charge. Subsequent re-edits will be charged hourly.

\* *GLIDE FX* cannot guarantee that any DVD it produces will work with all DVD players. Again, compatibility between any DVD burning software, hardware and/or players is NOT guaranteed.

\* Any balance is due and payable in full on or no later than ten(10) days after the contractual service date.
